

### A NATURALLY-OCCURRING PHENOMENON

Likely to occur if water carries iron, manganese, copper or sulfur

## Algae

### A NATURALLY-OCCURRING PHENOMENON

May appear as scum—red, green, black or blue green

Thick layers or blooms form when nutrients – mainly Phosphorus and Nitrogen occur in excess of natural amounts



### What can you do about Algae?


### Leave a natural buffer zone at the lake. Minimize run off.

### Have your soil tested.

### Use Zero phosphorus fertilizer, if you need to fertilize.

### Don't fertilize within 15 feet of the lake.


