Committee Reports

Finance Report: Moy reported a fund balance of \$18,958.21.Members discussed various dues payment options, the cost of using Paypal and the possibility of increasing dues. No action taken.

Long Range Planning/Communication and Website: Kiehle reported the website is down temporarily due to maintenance. The newsletter is being prepared for printing.

Lake Management-Treatment: Schnell reported that milfoil treatment is scheduled for June 22 and July 20. Twelve acres will be treated and affected homeowners will be notified.

Lake Management-Studies: Klein reported that spring water quality testing by interns is suspended due to coronavirus. Some water testing will be done by Klein and Lishawa .

Lake Management-Swimmer's Itch: Dahlstrom reported that the 2019 swimmer's itch report concluded that removal of ducks was not effective. Motion by Kiehle to suspend swimmer's itch studies in 2020, second by Cerny. Motion approved.

Lake Management-Prevention: Cerny reported that boat washing signs, provided by DEQ, have been installed at all 3 boat launches. Road cleanup is Saturday, May 23.

Water Safety: Sheriff Dept has been contacted regarding lake patrols. Patrol data has been submitted for the newsletter.

Fishing Quality and Loon Management: Motley reported there are 6 loon nesting sites. 4 are occupied. Brush Island and Ruth Lake sites have loons in the vicinity. The Fox Island nesting platform has been rebuilt. Walleye fishing has been very good this spring.

Membership/Nominations: Eckhoff reported the newsletter will be sent in June followed by a membership letter in July. Nominations for three board members are being accepted. The position of board president is also available.

Community Affairs: Lemcool reported that Long Lake Township has a licensing process for short term rentals.

Island Maintenance: Lemcool reported that island docks are in place.
